

Visa-related Enrolments and Fees

A visa subclass number identifies the conditions of enrolment in a Qld school.

Education Qld International (EQI) provides information on whether an enrolment needs to be processed first through EQI or directly by the school.

These students are required to apply for school enrolment through Education Qld International (EQI)

- **A student holding an international student visa (subclass 500 school sector).**
 - Enrolment in the MacGregor State High School International Student Program (ISP) or Study Abroad Program is arranged between EQI and International Staff at MacGregor State High school well before commencing school.
 - Often the family arranges for an agent to initiate and manage the enrolment through EQI.
 - Students will have a Confirmation of Enrolment (CoE) and school-based enrolment processes are also completed.
 - **Tuition fees cover** tuition costs, textbook hire and compulsory excursions.
 - **Tuition fees do not include** homestay accommodation fees, Overseas Student Health Cover (OSHC), enrolment admin fees, non-curriculum activities (e.g. instrumental music lessons) and non-compulsory excursions (e.g. the school ski trip), school IT levy, school uniforms and shoes, materials such as pens, calculators and other items of stationery, passport and visa fees, personal spending money, and public transport costs to and from school. - **A student who is a dependant of an international student (subclass 500 ELICOS, VET, higher education, etc.).**
 - They will have their parent's Confirmation of Enrolment (CoE) which provides information about the sector and duration of study.
 - An application is made to EQI, fees are paid and an EQI authority to enrol is provided via email, with a school notification form attached. Please refer to the MacGregor State High School website for details about enrolment.
 - Documentation from EQI must be presented to the Enrolment staff on application to attend MacGregor State High school. School enrolment processes take place.
 - In addition to the fees paid to EQI, the student pays the same user-pays fees charged by the school for all Australian students.
 - If the student's visa expires, the family must apply for another visa in order to stay in Australia. The Immigration Department may issue a bridging visa pending the decision on the new visa. The family must reapply to EQI and until the new visa is granted the student must continue to pay fees to EQI.

Students who have visas other than those above:

- **The conditions of other visa subclass fields may allow students to enquire about enrolment at MacGregor State High School.** Please refer to the MacGregor State High School website for details about enrolment.
 - **It is advised that the family checks their visa conditions** before making a school enrolment application. The school will check the visa conditions with EQI when an enrolment application is made.
 - **Will be enrolled as an International student on our school system** and pay the same fees as Australian students. Some bridging visas require other fee payments.
 - **Must not be enrolled past the expiry date of their visa.**
 - **Must advise the school of any changes to visa status.** Contact the International or enrolment staff
